Terms and Conditions of Membership

Application for Membership must be made on the Membership Application form. All details requested upon the Application Form must be completed and legible. Applications will only be accepted from persons who have attained the age of 18yrs. Applications must be accompanied by a form of Photographic Identity. Should the Applicant not possess Photo Identification, a minimum of three (3) other ID forms plus a Statutory Declaration must be completed together with this Application. The Club reserves the right to decline any membership application at its sole discretion.

Cazalys Palmerston Club is a Licensed Club with entry restricted to Members, Members Guests and Bona Fide Visitors.

Members

Please swipe your membership card on entry and sign in any guests.

Members Guests

Guest will be signed in by the club, at reception, using ID-Eye. Your guests will require photo ID to sign in.

Dress Standards

It is a requirement that all head wear be removed whilst on Club premises.

A neat and tidy appearance is required at all times.

No headwear, singlets on males, torn or dirty clothing is permitted at any time.

Code of Conduct

Club Patrons are required to behave in a manner conducive to the enjoyment of our facilities by all patrons.

Obscene and or offensive language or clothing will not be tolerated.

Minors are to be accompanied by a Parent, Adult spouse or Legal Guardian at all times.

The Club is committed to the principals of responsible service of alcohol, and will ensure that all persons in this Club adhere to these principals at all times.

Management's decision shall be final in all matters relating to dress and behaviour.

Management reserve the right to refuse entry and/or membership applications to any person at our sole discretion.

Smoking

Patrons are required to adhere to the smoking restrictions as in place throughout the Club. (NT Tobacco Control Act 2002)

Privacy

Cazalys Palmerston Club is subject to the provisions of the Privacy Act 1988. The personal information provided by you on this form/application and attached documents will be used to process your membership application. Failure to provide all if the requested information may result in your application being rejected. You have a right to access and correct any of your personal information that the Club holds about you.

The Club does not usually disclose your personal information to any other organisation or person unless there is a legal requirement to do so. The Club may disclose your information to third parties that provide services under contract to the Club. These contracts require the third party to keep your personal information confidential and secure.

Your personal information, including information about you obtained as a result of your placing your membership card in a gaming or other club machine (not ATM's), may be used by the Club for marketing purposes to improve our services and to provide you with the latest information about those services and any new related services and promotions.

The Palmerston Licensees Accord

The Licensees of Palmerston have determined and agreed to co-operate in the establishment and implementation of a standard of patron behaviour code with respect to their licensed venues.

The Licensees have hereby agreed on the following:-

Behavioral Standards

That standardised patron awareness signage will be prominently displayed in all bar areas.

That Management will support the staff in the enforcement of refusal of service to intoxicated patrons.

That staff will be appropriately trained in the requirements of the Responsible Service of Alcohol.

The Club reserves the right to provide details of patrons who have breached the Club's Code of Conduct to each of the signatories of the Palmerston Licensees Accord.

Underaae

That identification believed to be false/altered/fake is to be confiscated and forwarded to the OIC Palmerston Police, and the participating licensed venues.

Details of same will be forwarded to the signatories of the Palmerston Licensees Accord.

Drink Spiking

That details of alleged/reported drink spiking within the venue will be reported to the OIC Palmerston Police, and the participating licensed venues.

Details of same will be forwarded to the signatories of the Palmerston Licensees Accord.

Non Prescribed / Dangerous Drugs

That the venue will exclude any person(s) suspected of the sale and supply of illicit drugs within or around the licensed premises. Such actions will be reported to the OIC Palmerston Police, and the participating licensed venues.
